WAYS TO GIVE

Appreciated Securities

Gifts of appreciated securities (stocks, bonds, and mutual funds) may allow you a deduction for the current market value on the date of the gift and potentially avoid capital gains tax.

Real Estate

Gifts of real estate will allow you to receive the maximum tax deduction allowed by law, bypass capital gains tax, provide you an opportunity to establish a gift that provides an income for life, and make a significant donation.

Irrevocable Bequests (Wills & Trusts)

An irrevocable bequest provision in your will or trust will allow you to make a major gift to our program without reducing your current income.

Life Insurance

By designating Trinity Cafe as beneficiary of your policy, you can make a gift to our organization. Or, you may choose to transfer the ownership of the cash value of a life insurance policy.

Charitable Gift Annuities

A charitable gift annuity can provide payments to you for life and then support Trinity Cafe. Deferred gift annuities allow the option to make the gift today and receive the annuity later in life.

Charitable Remainder Trusts

These gifts allow you to make a substantial gift and receive income from the trust.

Memorials and Honorariums
